ADOPTION OF INCREASE OF LICENSING FEES FOR SANTA CLARA DEVEOPMENT CORPORATION

WHEREAS, The Santa Clara Pueblo Gaming Code establishes the Gaming Commission and was adopted through Resolution No. 98-2 on January 29, 1998. The Gaming Code has given authority to the Commission to enact policies and procedures for the proper administration of its activities.

WHEREAS, Section 109.6.B.2 states "To monitor, oversee and regulate the operation and conduct of all gaming and games of chance within Santa Clara lands, and to do such things as it deems necessary to assure that such gaming is conducted in full compliance with this Gaming Code, the Compact, the IGRA, and the regulation of the Commission."

NOW THEREFORE BE IT RESOLVED, that the Santa Clara Pueblo Gaming Commission, reaffirms that:

The Santa Clara Pueblo Gaming Commission formally adopts the increase in Gaming License Fees. With this increase this will help in covering all Background Investigation Fees. Background Investigations Fees have increased over the past few years and these increases have not been changed within the Commission.
